

# Parental Consent and Release Form

## 1 Consent to participation

- 1.1 You hereby consent to the Student participating in the Moot, which participation may include (but shall not be limited to):

## 2 Consent to the use of Photographs

- 2.3 The Company is the controller and responsible for the personal data comprising the Photographs, the Student's contact details and any related personal data.

## 3 Withdrawal of Consent

3.1 You have the right to withdraw the consent you have given at any time by telephoning the Company's Business Development team at +1 (345) 938 5022 or by writing to the

3.2 Upon the withdrawal of your consent the Company will no longer store the Photographs or Student's contact details. However, you acknowledge that the Company may be unable to remove Photographs that have been used in social media posts or in the local media.

### 4 Restrictions

- 4.1 The Company will:
  - (a) ensure that it complies with the requirements of all legislation and regulatory requirements in force from time to time relating to the use of the Photographs, the Student's contact details and any related personal data;
  - (b) ensure that the Photographs shall not represent the Student in a derogatory manner; and
  - (c) process the Photographs, the Student's contact details and any related personal data in accordance with the privacy notice attached at Schedule 1 to this letter, receipt of which you acknowledge by signing this letter.

Subject to these terms, I, the undersigned as Parent/Guardian of the Student, hereby grant permission for the above named Student to participate in the Moot and for Collas Crill to use the subsequent image(s) and/ or written work of the Student for the purposes of promoting the firm and the Moot.
