

# **Collas Crill supports Art for Guernsey's major exhibition - A Renaissance of Victor Hugo**

Daniel Hosego is one of the rising stars of the contemporary art scene. His colour-print artworks in particular place him as an artist at the inflexion point between a mathematically driven street artist and a Renaissance old master. His drawing skills and the robustness of his narratives are second to none and we expect that this show will have a revealing impact on Daniel's already blossoming international career.

David Ummels of Art for Guernsey said: 'Both artists are incredibly versatile and contemporary in their approach, while still strongly influenced by the Renaissance and its myriad symbols and metaphors. They were tasked with the daunting mission of revisiting the legacy of the ultimate 'Renaissance Man' in Guernsey, Victor Hugo, and specifically his novel Toilers of the Sea. Both artists have produced jaw-dropping, museum-quality artworks that will undoubtedly inspire our community and constitute a tier-one artistic legacy for the island.'
